EEG Services provide comprehensive patient-centered care and contributes to the understanding of epilepsy through diagnostic investigation, education and research. Reporting to the Manager, CNS Ambulatory Care & Epilepsy Monitoring Unit, the Certified EEG Technician is responsible for performing electroencephalograms related electrophysiological diagnostic activity in the inpatient and ambulatory care areas. Other responsibilities may include but are not limit to, 24-hour monitoring in the 2-bed Paediatric Epilepsy Unit (Victoria Hospital) and the 10-bed Epilepsy Monitoring Unit (University Hospital), including video monitoring; 24-hour monitoring of patients with surgically implanted (invasive) subdural/or grid electrodes; assisting the physician with cortical stimulation with invasive subdural and/or grid electrodes; performing prolonged EEGs intraoperatively, and conducting EEG.
